**Disaster preparedness to meet children's needs**

**Emergency Planning for Family Child Care (FCC) and Large Family Child Care (LFCC) Homes**

**Developing a written emergency plan is a new requirement for FCC and LFCC Licensees.** Through the combined efforts of the Delaware Emergency Management Agency (DEMA), Delaware Senior Corps, American Red Cross, RSVP, Delaware Citizens Corps, and local County emergency management agencies, FREE training is now available to help you meet the new licensing requirement. At the training, you will receive a template – a “fill in the blank” document – that you will use to start developing your emergency plan. The instructors will share their expertise on emergency planning including what needs to be in the plan based on meeting licensing requirements and latest best practices. Time will be allotted during the training to let you work on your own plan. During that time, the instructors will be available to address your individual concerns and answer questions. At the end of the training, you could have a nearly completed plan!!!
